#### Explanation of Responses:

- (1) Each restricted stock unit represents a contingent right to receive one share of ALOT common stock.
- (2) This amendment is being filed solely to reflect the reporting person's acquisition of 4,316 restricted stock units as derivative securities in Table II, rather than as non-derivative securities in Table I, as was timely reported on the reporting person's original Form 4. The original Form 4 was inconsistent with ALOT's practice for other restricted stock unit awards.
- (3) The restricted stock units vest in four equal annual installments beginning May 20, 2016.
