Explanation of Responses:

- (1) Includes 262.5378 shares which were previously reported on Table II as Common Stock Units held under the Company's Deferred Compensation Plan. Following an amendment to that Plan, those Common Stock Units may only be automatically settled in common stock on a one-for-one basis. Accordingly, those Common Stock Units may now be reported as the underlying shares on Table I. (See American Bar Association, December 20, 1996)(Q.4(d)(3)). In the future, additional acquisitions of Common Stock Units under the Plan will also be reported on Table I as directly owned shares of common stock.
- (2) Consists of shares held under the Company's 401(k) plan, The Manitowoc Company, Inc. RSVP Profit Sharing Plan, including 151.9798 shares acquired in transactions occurring between 12/31/02 and 12/31/03, which are exempt from Section 16(b) pursuant to Rule 16b-3 and exempt from reporting pursuant to Rule 16a-3(f)(1)(i)(B). The information in this report is based on a plan statement dated as of 12/31/03. From time to time the plan administrator collects maintenance fees related to the RSVP Plan, which may result in the number of shares held by a participant in the RSVP Plan declining by a marginal amount.
- (3) Options vested in 25% increments beginning on date indicated.
