- (3) The acquisition of these shares was not reported on a timely basis due to the fact that the Plan Administrator failed to notify the reporting person or the Company of the acquisition until December 29, 2003.
The Plan provides that the distribution date is the first day of the month following the participant's death, disability, termination of service/employment, a date specified by the participant or the earliest to occur of any combination of such options, at the election of the participant.
- (4) Distributions are payable in a lump sum, or in no more than 180 monthly, 60 quarterly or 15 annual installments, at the election of the participant.
