However, as of the close of business on April 27, 2016: i) Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 6,821,240 Class A Ordinary Shares; ii) ICS Opportunities, Ltd., an exempted limited company organized under the laws of the Cayman Islands ("ICS Opportunities"), beneficially owned 115,052 Class A Ordinary Shares; iii) Cognizant Holdings, Ltd., an exempted limited company organized under the laws of the Cayman Islands ("Cognizant Holdings"), beneficially owned 3,214,200 Class A Ordinary Shares (consisting of 2,486,900 Class A Ordinary Shares and listed options to purchase 727,300 Class A Ordinary Shares); and iv) Integrated Assets, Ltd., an exempted limited company organized under the laws of the Cayman Islands ("Integrated Assets"), beneficially owned 1,189,608 Class A Ordinary Shares, which collectively represented 11,340,100 Class A Ordinary Shares or 3.8% of the Issuer's Class A Ordinary Shares outstanding.

Millennium International Management LP, a Delaware limited partnership ("Millennium International Management"), is the investment manager to ICS Opportunities, Cognizant Holdings and Integrated Assets and may be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities, Cognizant Holdings and Integrated Assets.

Millennium International Management GP LLC, a Delaware limited liability company ("Millennium International Management GP"), is the general partner of Millennium International Management and may also be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities, Cognizant Holdings and Integrated Assets.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the general partner of the 100% shareholder of ICS Opportunities, Cognizant Holdings and Integrated Assets and may be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities, Cognizant Holdings and Integrated Assets.

Israel A. Englander, a United States citizen ("Mr. Englander"), is the managing member of Millennium International Management GP and Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies, ICS Opportunities, Cognizant Holdings and Integrated Assets.

The foregoing should not be construed in and of itself as an admission by Millennium International Management, Millennium International Management GP, Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies, ICS Opportunities, Cognizant Holdings or Integrated Assets, as the case may be.
