Explanation of Responses:

- (1) Upon the vesting of our restricted share units, the reporting person is required to pay the aggregate nominal value (par value), \$0.10 per share, of our Class A ordinary shares actually issued, in accordance with U.K. corporate law. In connection with the transaction reported above, the reporting person paid \$75.70 to Enscopl with respect to the shares actually issued upon vesting of the restricted share units. The remaining 621 shares were withheld and not issued to satisfy certain tax withholding obligations.
- (2) These shares were withheld to satisfy tax withholding obligations that arose upon vesting.
- (3) On June 3, 2013, the reporting person was granted 4,134 restricted share units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
