#### **Explanation of Responses:**

- (1) On July 14, 2009, Cliffs Natural Resources Inc. (the "Company") declared a dividend of \$.04 per share, payable to all holders of record as of August 14, 2009 of common stock payable on September 1, 2009. The amount shown reflects 3.5257 shares acquired pursuant to a Dividend Reinvestment and Stock Purchase Plan for the Company's Common Stock.
- (2) Convertible into Common Shares on a 1-for-1 basis.
- (3) Stock Units reflect number of Common Shares of underlying deferred compensation credited to the account of the Reporting Person pursuant to the Cliffs Natural Resources Inc. Nonemployee Directors' Compensation Plan ("Plan"). Each Stock Unit is generally distributable following termination of service as a Director.
- (4) The total includes dividend reinvestment pursuant to the Plan. The number of deferred dividend reinvestment equivalent shares earned in the Plan is calculated using the closing market price at the end of each quarter for shares held in the Plan. The reporting person was credited with 16.5383 dividend reinvestment shares on 9/30/2009.
