On May 1, 2006, Cleveland-Cliffs Inc (the "Company") received a letter from Ranko Cucuz withdrawing his name for consideration as a nominee for re-election to the Board of Directors of the Company at its Annual Meeting on May 9, 2006. Accordingly, the Board of Directors of the Company has determined, effective upon the expiration of Mr. Cucuz's term at the Annual Meeting, to decrease the size of the Board of Directors from 12 to 11.
