(the "Company") declared a dividend of \$.0875 per share, payable to all holders of record as of November 14, 2008 of common stock payable on December 1, 2008. The amount shown reflects 17.5097 shares credited to the Reporting Person pursuant to the Company's Dividend Reinvestment and Stock Purchase Plan.
- (2) Convertible into Common Shares on a 1-for-1 basis.
- (3) Reflects number of Common Shares underlying deferred compensation credited to the account of the Reporting Person in payment of 100% of the Reporting Person's Required Retainer fee under the Cliffs Natural Resources Inc. (formerly Cleveland-Cliffs Inc) Nonemployee Directors Compensation Plan ("Plan"). Each Stock Unit is generally distributable following termination of service as a Director.
- (4) The total includes dividend reinvestment pursuant to the Plan. The number of deferred dividend reinvestment equivalent shares earned in the Plan is calculated using the closing market price at the end of each quarter for shares held in the Plan. The reporting person was credited with 35.4483 dividend reinvestment shares on 12/31/2008.
