Balance also reflects 12 shares acquired September 1, 2005 pursuant to the dividend reinvestment feature of the VNQDC to shareholders of record as of August 12, 2005 and 1 additional dividend reinvestment share earned March 1, 2005 previously unreported.
- Held for the benefit of the Reporting Person by the Cleveland-Cliffs Inc Voluntary Non-Qualified Deferred Compensation Plan (VNQDC).
- On December 31, 2005 the Company issued a 2-for-1 stock split. The stock split adjusted the original number of options left in the last

report (3,334 ) to 6,668 options. The original conversion price of \$75.79688 was split in half to \$37.8984.
