- (2) The amount reflects 16.3952, 47.9570 and 61.3060 shares of Restricted Stock acquired on June 1, 2012, August 31, 2012 and December 3, 2012, respectively, pursuant to a dividend reinvestment feature of the Plan. The Board of Directors of Cliffs Natural Resources Inc. declared dividends of \$0.0625 per share, payable to all holders of record as of April 27, 2012, August 15, 2012 and November 23, 2012, respectively. The amount also reflects 2.9451, 3.870 and 4.9460 shares acquired on June 1, 2012, August 31, 2012 and December 3, 2012, respectively, pursuant to the Dividend Reinvestment and Stock Purchase Plan.
