- (4) Retention Units granted to Reporting Person under the Cleveland-Cliffs Inc Long-Term Incentive Program covering the period of January 1, 2005 to December 31, 2007 (Retention Period). Retention units were paid out to the Reporting Person in cash based on the market value price of the Common Shares of the Issuer on the last day of the Retention Period.
- (5) Total ownership of retention units reflects the 2-for-1 stock split on June 30, 2006, which resulted in the reporting person's receiving 435 additional retention units.
