- (2) Award of restricted stock pursuant to ACE Limited Long-Term Incentive Plan. Stock vests as follows: 1/3 on first anniversary of date of award, 1/3 on second anniversary of date of award, and 1/3 on third anniversary of date of award.
- (3) On February 17, 1998, the Ordinary Shares of ACE Limited split 3-for-1. Transactions prior to that date are thus reported on a pre-split basis, with respect to both the number of shares and, where applicable, the option exercise price. The totals in column 5 of Table I and column 9 of Table II have been adjusted, however, to give effect to the stock split.
- (4) Options become exercisable as follows: 1/3 on first anniversary of date of award, 1/3 on second anniversary of date of award, and 1/3 on third anniversary of date of award.
- (5) Option award pursuant to ACE Limited 1995 Long-Term Incentive Plan.
