Explanation of Responses:

- (1) Restricted stock units will vest 25% on each of the first, second, third and fourth anniversary dates provided the grantee remains continuously employed by the Company as of those respective dates.
- (2) The options become exercisable for 25% of the shares on each of the first, second, third, and fourth anniversary dates.
- (3) The options become exercisable for 40% of the shares on the first anniversary and 20% of the shares on the second, third and fourth anniversary dates.
- (4) There were two grants on February 16, 2007. The grant of 8,094 options become exercisable for 25% of the shares on each of the first, second, third and fourth anniversary dates. The grant of 7,501 options become exercisable for 33% of the shares on the first, second and third anniversary dates.
- (5) The options become exercisable for 25% of the shares on each of the second, third, fourth and fifth anniversary dates.
- (6) On December 6, 2005 the Board of Directors approved a motion to accelerate the vesting of all outstanding and unvested stock options that were awarded from 2002 - 2004.
