Upon the consummation of the Issuer's initial public offering on June 18, 2014, 40% of the shares subject to this option, plus an additional 1.667% of the shares for each month that occurred between August 7, 2013 and the consummation of the offering vested, and 1.667% of the shares will vest in equal monthly installments each month following the consummation of the offering until August 7, 2016.
