Conseco to recapture block of traditional life policies

Carmel, Ind., October 31, 2007 - Conseco, Inc. (NYSE: CNO), announced an agreement under which its Colonial Penn Life Insurance Company subsidiary ("Colonial Penn") will recapture a block of approximately \$50 million of annualized traditional life insurance premium in force that had been ceded in 2002 to Reassure America Life Insurance Company ("REALIC"), an affiliate of Swiss Reinsurance Company.

In the transaction, Colonial Penn will pay REALIC a recapture fee of \$63 million, recapture 100% of the liability for the future benefits previously ceded, and recognize profits as they emerge over time. Colonial Penn already administers the policies being recaptured. The transaction, which is to have an effective date of Oct. 1, 2007, will require insurance regulatory filings in several states and is expected to close by year-end.

Conseco CEO Jim Prieur said, "This transaction, which we expect to be immediately accretive to our earnings and return-on-equity, is part of our commitment to invest in the growth of Conseco's high-return core businesses and distribution channels. We will continue to allocate capital to those businesses where we can provide our customers and agents with differentiating products and services, and where we can provide our shareholders with the best long-term returns."
