This statement on Schedule 13G/A is filed following the transfer of shares of common stock of ARC Document Solutions, Inc., a Delaware corporation (the "Company") previously held indirectly by Mr. Suriyakumar through Micro Device, Inc. and Dieterich Post Company. Each of Micro Device, Inc. and Dieterich Post Company, of which Mr. Suriyakumar owned a 44% and 37.4% interest, respectively, were dissolved for estate planning purposes, and shares of the Company representing such interest were distributed to Mr. Suriyakumar's direct holdings. Mr. Suriyakumar did not receive any consideration with respect to these transactions.
