- (1) 100% of the Shares vest after four years of Continuous Service from the Date of Grant, however, vesting of the Shares will be fully accelerated to 100% if Participant's Continuous Service terminates before the fourth anniversary of the Date of Grant due to (i) death, (ii) Participant's becoming "Permanently Disabled," (iii) involuntary termination by the Company without "Cause," or (iv) termination by Participant with "Good Reason" (as such terms are defined in the November 29, 2006 Executive Employment Agreement between Company and Participant).
- (2) Twenty-five (25%) percent of the option vests on 12/4/07 and one-forty-eighth (1/48th) vests monthly for three (3) years thereafter.
