- (4) Mr. Suriyakumar has an ownership of 37.4% in Dieterich Post Company and serves on its board of directors so he could be deemed to have beneficial ownership of these shares. Mr. Suriyakumar disclaims beneficial ownership of these shares, except to the extent of his pecuniary interest therein.
- (5) Mr. Suriyakumar has an ownership of 44% in Micro Device, Inc. and serves on its board of directors so he could be deemed to have beneficial ownership of these shares. Mr. Suriyakumar disclaims beneficial ownership of these shares, except to the extent of his pecuniary interest therein.
