On March 11, 2008, the Registrant and CytRx Corporation ("CytRx") completed a partial spin-off of the Registrant from CytRx via the distribution and award of a portion of the Registrant's common stock held by CytRx to CytRx's stockholders. In connection with this partial spin-off and the related registration statement filed by the Registrant on Form S-1, extraordinary demands were placed on the personnel of both the Registrant and CytRx, including the accounting department of CytRx on whom the Registrant depends for the carve-out financial information for the Registrant's financial statements to be included in the Registrant's Annual Report on Form 10-K. As a result of these demands, the Registrant is unable to complete and file its Annual Report on Form 10-K for the fiscal year ended December 31, 2007 (the "Form 10-K") by the prescribed filing date without unreasonable effort and expense. The Registrant currently anticipates filing the Form 10-K on or before April 14, 2008.
