- (2) The restricted stock units shall vest in three equal installments over a three-year period commencing on the first anniversary of the date

of grant so that 100% of the restricted stock units will be vested as of June 21, 2015.

- (3) Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock.
- (4) The restricted stock units vest in three equal installments over a three-year period commencing on the first anniversary of the date of grant so that 100% of the restricted stock units will be vested as of May 23, 2016.
