Explanation of Responses:

- (1) 25% of the shares subject to this option will vest on May 23, 2014, and an additional 25% of the shares subject to this option will vest annually thereafter, such that 100% of the shares subject to this option will be fully vested on May 23, 2017. This option also provides for accelerated vesting in the event that the Reporting Person's employment is terminated in connection with an acquisition of the Issuer.
- (2) The restricted stock units shall vest in three equal installments over a three-year period commencing on the first anniversary of the date of grant so that 100% of the restricted stock units will be vested as of May 23, 2016. These restricted stock units also provide for accelerated vesting in the event that the Reporting Person's employment is terminated in connection with an acquisition of the Issuer.
- (3) Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock.
