Explanation of Responses:

- (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) The Reporting Person is a newly formed limited partnership formed for the purpose of receiving shares of Class B Common Stock from Texas 8-26-22 Trust 2. On July 27, 2012, Texas 8-26-22 Trust 2 contributed its 1,879,132 shares of Class B Common Stock to the Reporting Person, whose general partner is 8-26-22 GP LLC and whose limited partner is Texas 8-26-22 Trust 2. Texas 8-26-22 Trust 2 is the sole member of 8-26-22 GP LLC, the general partner of the Reporting Person.

- (3) No consideration was paid in connection the contribution, which constitutes a "permitted transfer" as defined in the Issuer's Amended and Restated Certificate of Incorporation. The Reporting Person has executed a joinder to and become subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following such contribution, the shares remained shares of Class B Common Stock.

Remarks:

The Reporting Person may be deemed to be a member of a 10% owner group because the Reporting Person has agreed to certain voting agreements and limitations on transfers of shares of Class A Common Stock and Class B Common Stock. The Reporting Person disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest therein.
