In addition, the Reporting Person may be deemed to be a member of the a group because the Reporting Person has agreed to certain voting agreements and limitations on tranfers of Class A Common Stock and Class B Common Stock. The Reporting Person disclaims beneficial ownership of the securiites reported herein except to the extent of its pecuniary interest therein.
