The original Form 3 over-reported the number of shares beneficially owned at 4,093 shares because it did not account for the 686 shares of Class A Common Stock withheld by the Issuer upon issuance of certain shares in settlement of vested restricted stock units to cover applicable taxes. The corrected number set forth in this amended Form 3 reflects such withholding by the Issuer, for a net total of 3,407 shares of Class A Common Stock.
