- As provided in the Issuer's Certificate, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock converts automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Certificate.

Remarks:

Member of 10% owner group. Marshall E. Eisenberg serves as trustee of A.N.P. Trust #2M6, the Reporting Person, and has investment power

over the shares beneficially owned by A.N.P. Trust #2M6. The beneficiary does not have investment power over the shares of Class B Common Stock held by A.N.P. Trust #2M6. In addition, A.N.P. Trust #2M6 may be deemed to be a member of a group because A.N.P. Trust #2M6 has agreed to certain voting agreements and limitations on transfers of shares of Class A Common Stock and Class B Common Stock. A.N.P. Trust #2M6 disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest therein.
