As of December 31, 2015, (i) 61,382,506 shares of Class B Common Stock were held of record by the Jack Dorsey Revocable Trust u/a/d 12/8/10, for which Mr. Dorsey serves as trustee, (ii) 7,952,826 shares of Class B Common Stock were held of record by the Jack Dorsey Remainder Trust u/a/d 6/23/10, for which Mr. Dorsey serves as trustee, and (iii) 168,750 shares were held of record by West Studios, LLC, for which Mr. Dorsey serves as a managing member and shares voting and dispositive power.

Each share of Class B Common Stock is convertible into one share of Class A Common Stock at the option of the holder and has no expiration date. Each share of Class B Common Stock is entitled to ten votes per share, whereas each share of Class A Common Stock is entitled to one vote per share. The rights of the holders of Class A Common Stock and Class B Common Stock are identical, except with respect to the aforementioned conversion rights and voting rights.

The ownership percentage above is calculated based on 31,717,133 shares of Class A Common Stock outstanding as of December 31, 2015, as reported by the issuer to the reporting person, plus the assumed conversion of 69,504,082 shares of Class B Common Stock deemed beneficially owned by Mr. Dorsey, as described herein, into shares of Class A Common Stock.
