Company terminates prior to the first anniversary of the date of grant, the RSUs will vest pro-rata based on the number of days from the date of grant through  
and including the date of the reporting person's termination of service. The RSUs will also vest in full in the event of the reporting person's death or disability.

( ) Settlement of this award will be satisfied through the issuance of one ordinary share for each vested RSU.
