**Explanation of Responses:**

(1) Represents shares withheld by the Company to cover tax withholding obligations upon the vesting of restricted shares.

( 2) Granted on June 15, 2015 pursuant to the Michael Kors Holdings Limited Omnibus Incentive Plan (the "Incentive Plan"). These securities will vest 25% each year on June 15, 2016, 2017, 2018, and 2019, respectively, subject to grantee's continued employment with the Company through the vesting date.

( 3) The RSUs do not expire.

( 4) Settlement of this award will be satisfied through the issuance of one ordinary share for each vested RSU.

( 5) Granted on June 2, 2014 pursuant to the Incentive Plan. 50% of these share options are immediately exercisable. The remaining unvested share options will vest 50% each year on June 2, 2017 and 2018, respectively, subject to grantee's continued employment with the Company through the vesting date.

( 6) Immediately exercisable.

( 7) Granted on June 3, 2013 pursuant to the Incentive Plan. 75% of these share options are immediately exercisable. The remaining unvested share options will vest on June 3, 2017, subject to grantee's continued employment with the Company through the vesting date.
