- (1) This Form 4/A is filed to amend the transaction date for the exercise of the option to 04/03/2014 from previously reported 04/09/2014.
- (2) This Form 4/A is filed to amend the value of the shares withheld at the time of exercise to \$26.00 from previously reported \$35.31 to accurately reflect the market price of the shares on the correct transaction date of the option exercise.
- (3) The option became exercisable as to 250,000 shares on June 6, 2012, of which 50,000 shares were exercised prior to April 3, 2014. Beginning on July 6, 2012 and continuing monthly until March 6, 2015, the option vested or will vest in equal amounts, representing 1/48 of the total number of shares covered by the option, except that the final vest, occurring on April 6, 2015, will be an option for 20,833 shares. On February 8, 2014, 25% of the portion of the option that would have remained unvested on August 8, 2014 became exercisable. All vesting of Mr. Zabusky's option is subject to his continued status as an employee.
