Explanation of Responses:

- (1) Held directly by Randall J. Garutti, the spouse of Maria L. Garutti. For more information, see the Form 4 filed by Randall J. Garutti on February 6, 2015.
- (2) Acquired by the Randall J. Garutti 2014 GST Trust and Randall J. Garutti, as applicable, pursuant to a subscription agreement entered into with the Issuer in connection with the closing of the Issuer's initial public offering on February 4, 2015 (the "IPO"). One share of the Issuer's Class B common stock, par value \$0.001 per share (the "Class B Common Stock"), was issued for each common membership interest in SSE Holdings, LLC (each an "LLC Interest") received pursuant to a reclassification of SSE Holdings, LLC that occurred in connection with the closing of the IPO. Pursuant to the Amended and Restated Certificate of Incorporation of the Issuer filed in connection with the IPO, the shares of Class B Common Stock (i) confer no incidents of economic ownership on the holders thereof, (ii) only confer voting rights on the holders thereof and (iii) may only be issued, on a one-for-one basis, to the permitted holders of LLC Interests.
- (3) Held directly by the Randall J. Garutti 2014 GST Trust, of which Ronald J. Garutti, Jr. and Maria L. Garutti are co-trustees. Each of Ronald J. Garutti, Jr. and Maria L. Garutti disclaims beneficial ownership over such shares and LLC Interests, except to the extent of his / her pecuniary interest therein.
- (4) The option vests in five equal annual installments on each of the next five anniversaries of the grant date, subject to Randall Garutti's continued service with the Issuer.
- (5) Represents LLC Interests which are redeemable for an equal number of shares of the Issuer's Class A Common Stock or, at the election of the Issuer, cash equal to the volume-weighted average market price of such shares. The LLC Interests have no expiration date.
- (6) Issued pursuant to a reclassification of SSE Holdings, LLC that occurred in connection with the closing of the IPO. The units in SSE Holdings, LLC held by the Trust and Randall J. Garutti, as applicable, prior to the reclassification were cancelled as part of the reclassification. The reclassification is further described in the Third Amended and Restated Limited Liability Company Agreement of SSE Holdings, LLC, which was filed with the Securities and Exchange Commission on January 20, 2015 as Exhibit 10.3 to Amendment No. 1 of the Issuer's Registration Statement on Form S-1.
