## **Explanation of Responses:**

- (1) The shares of Class B common stock were acquired through the conversion of Class B exchangeable shares of Molson Coors Canada Inc. on a one-for-one basis.
- (2) The price reported represents the weighted average sales price of shares of Class B common stock sold in multiple transactions at prices ranging from \$53.50 to \$53.51, inclusive. The reporting person will provide to the issuer, any security holder of the issuer, or the SEC staff, upon request, information regarding the number of shares sold at each price within the range.
- (3) Class B exchangeable shares of Molson Coors Canada Inc. are convertible, on a one-for-one basis, for shares of the issuer's Class B common stock.

- (4) Class B exchangeable shares are convertible at any time.
- (5) There is no expiration date.
- (6) As adjusted to give effect to the 2-for-1 stock split that occurred on October 3, 2007.
