**Explanation of Responses:**

- (1) Represents 5,479 shares of the Issuer's Class A Common Stock purchased for the Reporting Person's account under the Issuer's Employee Stock Purchase Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisitions are exempt from Section 16 reporting requirements pursuant to Rule 16b-3.
- (2) Represents 343 shares of the Issuer's Class A Common Stock acquired by the Retirement Savings Plan of Tyson Foods, Inc. on behalf of the Reporting Person and pursuant to a dividend reinvestment feature since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisition is exempt from Section 16 reporting requirements pursuant to Rule 16a-11.
- (3) These shares were sold pursuant to a requirement of the Retirement Savings Plan of Tyson Foods, Inc. that all participants in the plan, which included the Reporting Person, divest any shares of the Issuer held by the plan on their behalf. The Reporting Person has voluntarily sold the shares in advance of January 3, 2011, the date on which the plan will begin selling, on behalf of the plan participants,

any previously unsold shares of the Issuer.
