- (2) Includes 682 Shares purchased from 12-01-03 thru 12-31-03, for the reporting person's account under the Tyson Foods, Inc. Employee Stock Purchase Plan which transactions are exempt under Section 16b-3.
- (3) The Stock Options become exercisable in five equal annual installments, commencing three years after date of grant 6/1/95.
- (4) The stock options become exercisable in five equal annual installments, commencing three years after date of grant 11/20/95.
- (5) The Stock Options become exercisable in five equal annual installments commencing three years after the date of grant 10/3/96.
- (6) The stock option vests at 40% on 10-15-03 and 20% each year thereafter.
- (7) The Stock Option vests at 40% on 10-10-04 and 20% each year thereafter for 3 years.
- (8) This Stock Option vests at 40% on 9-19-05 and 20% each year thereafter for three (3) years.
- (9) Because of a clerical error, this date was previously reported incorrectly.
- (10) The Stock Options become exercisable in four equal annual installments, commencing two years after the date of grant, 03-29-01.
