Explanation of Responses:

- Represents 449 shares of the Issuer's restricted Class A Common Stock acquired by the Reporting Person pursuant to a dividend reinvestment feature under the Issuer's 2000 Stock Incentive Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisition is exempt from Section 16 reporting requirements pursuant to Rule 16a-11.
- On Sunday, October 4, 2009, 27,933 shares of restricted Class A Common Stock vested. The award of these restricted shares to the Reporting Person has previously been reported. Pursuant to an election made by the Reporting Person, 9,344 shares were sold by the Reporting Person to the Issuer on Monday, October 5, 2009, to satisfy tax withholding obligations related to the vesting.
- Award of restricted Class A Common Stock pursuant to the Issuer's 2000 Stock Incentive Plan to vest on October 5, 2012, pursuant to his employment agreement.
- Represents 3,586 shares of the Issuer's Class A Common Stock purchased for the Reporting Person's account under the Issuer's

Employee Stock Purchase Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisitions are exempt from Section 16 reporting requirements pursuant to Rule 16b-3.
