**Explanation of Responses:**

- (1) Represents shares of the Issuer's Class A Common Stock received by the Reporting Person September 14, 2012, pursuant to a dividend reinvestment feature under the Issuer's stock plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisitions are exempt from Section 16 reporting requirements pursuant to Rule 16a-11.
- (2) Represents shares of the Issuer's Class A Common Stock purchased for the Reporting Person's account under the Issuer's Employee Stock Purchase Plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. Such acquisitions are exempt from Section 16 reporting requirements pursuant to Rule 16b-3.
- (3) On October 5, 2012, 17,104 shares of restricted Class A Common Stock vested. The award of these restricted shares to the Reporting Person has previously been reported. Pursuant to an election made by the Reporting Person, 6,404 shares were sold by the Reporting Person to the Issuer on October 5, 2012, to satisfy tax withholding obligations related to the vesting.
