- (3) Represents a stock award for shares of the Issuer's Class A Common Stock having a value of \$125,000 granted on the date of election as a director at the 2014 Annual Meeting of Shareholders (January 31, 2014). Per the Issuer's Director Compensation Policy, the Reporting Person elected to take this stock award in lieu of a deferred stock award otherwise granted to the Issuer's non-employee directors.
