Explanation of Responses:

- (1) Represents shares of the Issuer's Class A Common Stock received by the Reporting Person pursuant to a dividend reinvestment feature under Issuer's stock plan since the last Statement of Changes in Beneficial Ownership was filed by the Reporting Person. - (2) Includes 6,649 shares of the Issuer's Class A Common Stock acquired by the Reporting Person pursuant to the Deferred Fee Plan for Directors, which shares shall vest 180 days after termination of the Reporting Person's service as a member of the Issuer's board of directors.
- (3) Represents a stock award for shares of the Issuer's Class A Common Stock having a value of \$150,000 granted on the date of election as a director at the Annual Meeting of Shareholders held on January 30, 2015. Per the Issuer's Director Compensation Policy, the Reporting Person elected to take this stock award in lieu of a deferred stock award otherwise granted to the Issuer's non-employee directors.
