Explanation of Responses:

- (1) The number of restricted shares has increased by 951 shares since the last filed Form 4 due to the reinvestment of dividends on the restricted shares, which dividend reinvestment is a non-reportable event.
- (2) Includes 2,088 shares purchased from 09-01-03 through 12-31-03 for the reporting person's account under the Tyson Foods, Inc Employee Stock Purchase Plan which transactions are exempt under Section 16b-3.
- (3) All options granted prior to the closing of the tender offer for IBP vested on 7/23/01. For all other options, 40% of the options are exercisable two years after the grant date (the date listed above represents the date 40% become exercisable), and an additional 20% vest in each of the following three years. After 5 years 100% of the options are exercisable.
- (4) The Stock Option vests at 40% on 10-10-04 and 20% each year thereafter for 3 years.
- (5) This Stock Option vests at 40% on 9-19-05 and 20% each year thereafter for three (3) years.
