- Shares withheld by the Company to satisfy tax withholding obligations upon vesting of restricted shares; not an open market transaction.
- Shares held in account under NIKE, Inc. Employee Stock Purchase Plan.
- Shares held in account under the NIKE, Inc. 401(k) and Profit Sharing Plan.
- Stock Option granted under the NIKE, Inc. 1990 Stock Incentive Plan on 07/19/2013 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
