- Includes 35,822 restricted shares granted under the NIKE, Inc. 1990 Stock Incentive Plan.
- Shares held in account under the NIKE, Inc. 401(K) and Profit Sharing Plan.
- Option granted on 7/23/1999 and became exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
