- (4) Shares held in account under NIKE, Inc. Employee Stock Purchase Plan.

(5) Shares held in account under the NIKE, Inc. 401(K) and Profit Sharing Plan.

(6) Option granted on 2/16/2006 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
