Explanation of Responses:

- (2) The reporting person converted 10,000,000 shares of Class A Common Stock at a fixed conversion ratio of one share of Class A Common Stock for one share of Class B Common Stock, resulting in his acquisition of 10,000,000 shares of Class B Common Stock, pursuant to a Rule 10b5-1 Trading Plan.
- (3) Class A Common Stock is convertible at any time on a one-for-one basis into Class B Common Stock with no expiration date.
- (4) Transaction pursuant to a Rule 10b5-1 Plan.
- (5) Shares held by a corporation owned by wife. The reporting person disclaims beneficial ownership of these securities and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for purposes of Section 16 or any other purpose.
