The restrictions lapse with respect to one-third of the shares on each of the first three anniversaries of the grant date; and upon any termination of employment, any shares as to which the restrictions have not expired shall be forfeited to NIKE for cancellation and become authorized but unissued shares.
- (2) Restricted Stock Unit ("RSU") granted under the NIKE, Inc. 1990 Stock Incentive Plan. All of the RSUs shall vest 100% with respect to

the total number of RSUs on the fifth anniversary of the Grant Date; and upon any termination of employment, any units that have not vested shall be forfeited to the Corporation.

- (3) Shares held in account under NIKE, Inc. Employee Stock Purchase Plan.
- (4) Shares held in account under the NIKE, Inc. 401(k) and Profit Sharing Plan.
- (5) John F. Slusher, Trustee of Jennifer Nadia Slusher Trust
- (6) Stock Option granted under the NIKE, Inc. 1990 Stock Incentive Plan on 07/20/2012 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
