account under the NIKE, Inc. Retirement Savings Plan and 417 shares indirectly, in account under the NIKE, Inc. Employee Stock Purchase Plan.

- (3) Option granted for 33,000 shares on 7/18/2003 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
