- (3) Each Restricted Stock Unit represents a contingent right to receive the economic equivalent of one share of the Company's common stock. The Restricted Stock Units will be settled, at the reporting person's election, in shares of comon stock or 50% in common stock and 50% in cash.
- (4) Represents shares of common stock received by the individual in settlement of dividend rights granted in connection with the 2010 and 2011 Restricted Stock Unit grants.
- (5) The Restricted Stock Units award was granted and was effective in July 2009 and vests in three equal annual installments beginning on February 20, 2010. Since February 20, 2012 was a holiday, the Restricted Stock Units vested on February 17, 2012.
- (6) The Restricted Stock Units award was granted and was effective in July 2009 and vests in four equal annual installments beginning on February 20, 2010. Since February 20, 2012 was a holiday, the Restricted Stock Units vested on February 17, 2012.
- (7) The Restricted Stock Units award was granted and was effective in February 2010, and vests in four equal, annual installments beginning on February 20, 2011. Since February 20, 2012 was a holiday, the Restricted Stock Units vested and were released on February 17, 2012.
- (8) The Restricted Stock Units award was granted and was effective in February 2011, and vests in four equal, annual installments beginning on February 20, 2012. Since February 20, 2012 was a holiday, the Restricted Stock Units vested and were released on February 17, 2012.
