This Amendment No. 1 to the statement on Schedule 13D, dated June 29, 1998 (the "Schedule 13D"), of Citigroup Inc. (formerly Travelers Group Inc.) is being filed with respect to the Ordinary Shares of 0.5 p each (the "Ordinary Shares") of Signet Group plc, a public limited company incorporated in England (the "Issuer").

#### Item 5. INTEREST IN SECURITIES OF THE ISSUER.

(a) and (b) This item as set forth in the Schedule 13D is deleted and the following is inserted in its place:

As of October 21, 1998, SBUKE (and Citigroup, SSBH, SBHC, Salomon Brothers Europe Limited, Salomon International Limited and Salomon (International) Finance AG) may be deemed to beneficially own 47,793,247 Ordinary Shares, which includes 3,428,970 Ordinary Shares represented by 114,299 American Depositary Shares ("ADSs"). 47,793,247 Ordinary Shares represents 2.8% of the outstanding Ordinary Shares (based on 1,674,842,749 Ordinary Shares outstanding, as reported in the Issuer's Form 6-K for the month August 1998). As SBUKE (and Citigroup, SSBH, SBHC, Salomon Brothers Europe Limited, Salomon International Limited and Salomon (International) Finance AG) no longer owns 5% or more of the Ordinary Shares, this Schedule 13D is hereby terminated."
