Explanation of Responses:

- (1) These shares are held in a trust for the benefit of the reporting person's children. The reporting person's spouse is a trustee of the trust. - (2) Each phantom share/restricted stock unit will be paid in one share of common stock.
- (3) Number of performance restricted stock units that vested on 2/6/13 upon certification by the Issuer's compensation committee. The reporting person had previously reported all of the 981 vested and unvested performance restricted stock units associated with this award, of which 530 had been vested prior to 2/6/13. As of 2/6/13, 765 of these units are vested in total, and 216 have been forfeited.
