- (1) As trustee of the Suriyakumar Family Trust, which owns 114,613 shares of Common Stock following the disposition of 7,529 shares. Represents 283,749 shares disposed of by OCB Reprographics, Inc. Kumarakulasingam Suriyakumar is a director and owns an ownership interest of 17.6% in OCB Reprographics, Inc. Kumarakulasingam Suriyakumar disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
- (2) Represents 50,605 shares disposed of by Color Expressions of California, Inc. Kumarakulasingam Suriyakumar is a director and owns an ownership interest of 19.5% in Color Expressions of California, Inc. Kumarakulasingam Suriyakumar disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
- (3) Represents 434,522 shares disposed of by Micro Device, Inc. Kumarakulasingam Suriyakumar owns an ownership interest of 44% in Micro Device, Inc. Kumarakulasingam Suriyakumar disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
- (4) Represents 102,069 shares disposed of by Brownies Blueprint, Inc. Kumarakulasingam Suriyakumar is a director and owns an ownership interest of 33% in Brownies Blueprint, Inc. Kumarakulasingam Suriyakumar disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
