- (2) The aggregate number of shares beneficially owned does not match Mr. Formolo's Form 4 filed on May 23, 2007 due to an interim distribution of shares by CHS Management IV LP, which was exempt from Section 16 pursuant to Rule 16a-13.
- (3) Thomas J. Formolo is a partner of Danish-Italian Investors, L.P., Series A. Mr. Formolo could be deemed to have beneficial ownership of all of these shares but disclaims beneficial ownership except to the extent of his pecuniary interest therein.
