- (1) Each restricted stock unit ("RSU") represents the contingent right to receive one share of Class A Common Stock.
- (2) The RSUs issued pursuant to the Second Amended and Restated Hyatt Hotels Long-Term Incentive Plan (the "LTIP") vest and become payable in four annual installments of 50%, 30%, 10% and 10%, respectively, beginning on March 16, 2016. The RSUs will be settled in shares of Class A Common Stock upon vesting, subject to earlier settlement upon death or disability or a change of control of the Issuer.
- (3) The stock appreciation rights issued pursuant to the LTIP vest on March 16, 2018.
